



What warranty does Mob Armor offer?

### **SOLVE-IT! PRODUCTS LIMITED WARRANTY**

If a material or workmanship defect arises with regard to any Solve-It! product and a valid claim is received within the Warranty Period, Solve-It! will (1) repair the product using new or refurbished parts or (2) replace the product with a new or refurbished Solve-It! product. For purposes of this limited warranty, “refurbished” means a product or part that has been substantially returned to its original specifications. In the event of a defect, these are your exclusive remedies. Solve-It! reserves the right to charge a small shipping and handling fee in connection with the fulfillment of any valid claim.
