1. Adjust the holder to fit your device: Loosen the screws on the front side of the holder, as well as the screw on the adjustable arm. Pull the adjustable sides apart and pull out the adjustable arm.

Slide your device into the holder. Press the sides together so the device is firmly in place. Place the spring block onto the adjustable arm and press it toward the device.



2. Remove the spring block carefully, keeping the adjustable arm exactly in position. Remove the device carefully, making sure the side arms stay exactly in position. Fix the size of the holder by tightening the screws on front of the holder as well as the screw on the adjustable arm.



3. Install the holder: Loosen the screw in the center of the holder so you can remove the tilt swivel base plate on the back. Place the base plate onto the desired position and screw into place with the enclosed screws.

Place the holder over the attaching plate so the screw fits in the hole in the tilt swivel. Tighten the screw until the holder is firmly in place, but can still be adjusted.



4. The holder is in place.
